**Regular Meeting**

**Members Present:** Supervisor Robert Corrin, Clerk Sue Emmendorfer, Treasurer Cathy Gross; Trustees: Kevin Carlton, William Hedrich, Peter Hemgesberg, and Ken Hornak.

**Public Comments:** Clerk candidates introduced themselves to the board: Fran Kukulis; Corin Mittan; Tina Powell; and Clare Drexler.

**Committee/Board Reports:**

SCTOA – Hornak reminded the board of the association's April 11, 2012 spring meeting date at James Township.

Cemetery – Hemgesberg reported on mausoleum door replacement plans; spring clean up is completed; Ftc&h has been out to the riverbank and reported it is coming along as expected.

Park & Rec – Carlton noted spring cleanup in the park is underway and trees will be planted in the campground.

Rehmann Health Center – Gross noted the United Appeal will make its distribution later in the month.

Fire Board – Corrin reported new state firefighter rules are making it harder to train and keep volunteer firefighters.

MMWA – Emmendorfer reported on a performance review of the MMWA General Manager; next regular meeting April 9.

Supervisor – Corrin reported the county road commission will probably remain as currently organized; noted the next annual Zoning Board of Appeals meeting will be April 3, 2013; the new assessor is in the office each Monday 1 to 5; March Board of Review saw 38 petitions.

Clerk – Emmendorfer noted an April 10, 2012 state provided elections training and area clerk's meeting at Thomas Township.

Treasurer – Gross the tax season is settled with the county with 94% of the taxes collected, up one percent from last year; \$236,000 in delinquent taxes were returned to the county for collection.

- Motion by Emmendorfer, support by Gross, to amend Fiscal Year 2011-2012 General Fund Budget \$150 to Cemetery, \$150 to Street Lights, \$2300 to Assessing, with \$1600 from General Administration and \$1000 from Data Processing. Motion Carried.
- Motion by Hemgesberg, support by Gross, to hold a special meeting 6 p.m. April 9, 2012, for the purpose of appointing a new township clerk to complete the current term. Motion Carried.
