Chesaning Township Minutes Regular Meeting November 5, 2015 @ 7:30 p.m.

Regular Meeting: Called to order at 7:31 p.m.

Pledge of Allegiance

Members Present: Supervisor Robert Corrin, Clerk Frances Kukulis, Treasurer Cathy Gross; Trustees: William Hedrich,

Ken Hornak and Peter Hemgesberg

Members Absent: Trustee Kevin Carlton

Approval of Agenda: Agenda was presented for approval.

Approval of Minutes: Minutes of the Regular Board Meeting of October 1, 2015 were presented for approval.

<u>Public Comments:</u> None <u>Committee/Board Reports:</u>

County Commissioner – No one present to report.

County Road Commission – No one present to report, monthly report of activity has been received.

SCTOA – Hornak noted no meeting was held.

Cemetery – Hemgesberg noted water is off, Hedrich repaired one water valve and will be repairing a second soon, no dumping signs are posted, trees on property adjacent to cemetery have been removed by property owner, and fall clean-up has been completed. Corrin noted no word has come back from the County regarding the drainage issue and survey the engineer did.

Building Official – No one present to report. Corrin noted a substantial number of permits for small construction projects have been issued; an issue of a licensed contractor installing generators and not pulling electrical permits has been discovered and will be addressed.

Ordinance Enforcement Officer – No one present to report. Corrin noted the Chesaning Road property clean-up issue continues and will be going to court; an issue on Corunna Road continues, a complaint filed by the Sheriff's Department has been dismissed for insufficient evidence, the Township will have to proceed another way to attempt to resolve the issue.

Parks & Rec – No one present to report.

Rehmann Health Center – No Health Center meeting was held. United Appeal met October 12 and stuffed and mailed 6,000 envelopes, money is coming in with this years' fund-raising goal \$30,000 again; a large donation of \$1,000 has been received from the Lions Club.

Fire Board – Corrin noted the Fire Department is hosting a pig roast November 7 from 4-7 pm; the insurance risk manager has been in and reviewed the vehicle insurance; fire-fighter Ryan has been cleared to return to work; a fire preservation activity was put on at Big Rock Elementary in early October; the paging system has been having troubles; a Craft Bazaar was held on October 24.

MMWA – Kukulis reported the October meeting was cancelled since two special meetings were held in September; the next meeting will be held in December.

Task Force – Corrin noted committee reports were given; two representatives from Mobile Medical Response were speakers at the meeting and discussed the operation, staffing, and the new location; when bridge work begins next year it is expected to present some call response timing issues for both the ambulance and fire-fighting services; the Village Manager and President were at the meeting and asked that a strategic plan for the community be implemented.

Board Officials Reports:

Supervisor – Corrin asked Planning Commission Member Hemgesberg to report on the November 4 meetings. Hemgesberg noted a special meeting/public hearing was held to consider a special use to allow a drive-thru on a proposed new restaurant; questions regarding parking spaces, and traffic flow were addressed prior to the special use being approved; Building Official Kehoe will work with the property owner to address the issues; the regular quarterly meeting was also held November 4; right-to-farm, corn stalks clogging county ditches during heavy rains, the fence ordinance, and marijuana legislation were discussed; meeting dates for next year were additionally set. Corrin reported both he and Carlton are signed up to attend the MTA Conference in January; an AMAR Review, an audit of the township's assessing practices,

has been completed and a good report has been received; the County continues discussion on a countywide 2 mill road proposal; a road funding proposal for state and federal roadways has been passed; legislation allowing voting by phone is expected to be addressed by the State; the Stream Team met on October 26 to collect bugs and check the environment of the river, bugs were sorted and graded and the river was rated good.

Clerk – Kukulis stated amendments to the cemetery ordinance and clean-up work on the cemetery management program continues; preparation for the March 8 Presidential Primary has begun; a FOIA was received and replied to regarding the number of eligible voters and registered voters; December 8 is the Administrative Assistant's one-year anniversary.

Treasurer – Gross noted a State Revenue Sharing check in the amount of \$30,085 down \$623 from the same period last year was received; Summer taxes are being collected with 3% interest added, an additional 1% per month will be added until they go delinquent to the County; clean-up work and preparation for the Winter tax season is in process including clean-up of principal residence exemptions; property splits will no longer carry the street number of the parent parcel on a vacant parcel generated from a split, the road name will be used as the address only.

Unfinished Business:

Cemetery Drainage – Hedrich stated depending on the cost of the County proposal to fix the drainage issue the Township may need to consider putting in a ditch instead.

New Business:

Consider Adoption America Recycles Day Proclamation – The Board was presented a proclamation promoting and recognizing the benefits of recycling for their consideration.

Consider PA 116 Application—Darlene M. Pumford – The Board was presented a PA116 application for their consideration.

Extended Public Comment: None

Extended Township Board Comment: Hedrich noted someone had dumped a clay substance at the base of the drive in Parshallburg Park that had to be removed and the gravel roadway repaired.
